# I GENERAL INFORMATION

The Coordination of the Postgraduate Program in Administration (PPGAdm), of the Center for Legal and Economic Sciences, of the Federal University of Espirito Santo, makes public the rules of the Simplified Selection Process for filling positions for granting postdoctoral scholarships, by the requirements of the Support Program for Emerging Capixabas Postgraduate Programs (FAPES Notice No. 04/2022 – PROAPEM), Resolution No. 171/2017 of CCAF/FAPES and Resolution No. 18/2021 of CEPE / UFES.

# II SCHOLARSHIPS

The PROAPEM/FAPES postdoctoral scholarship lasts 12 months for Brazilians and 10 or 12 months for foreigners. The monthly value of the scholarship is 5,500.00 BRL.

# **III REGISTRATION**

Registration will occur between November 24, 2023, and December 8, 2023, via electronic mail (e-mail) until the deadline for registration. The following documents must be sent to ppgadm@gmail.com:

- 1) Registration form (Appendix 1).
- 2) Curriculum Plataforma Lattes (or equivalent for foreign candidates).
- 3) Documentation supporting the curriculum.
- 4) Work plan.

# **IV POSITIONS**

Two positions will be offered, one for each modality: Brazilian candidates (one position) and foreign candidates (one position). If there are no applications for one of the modalities, the position will automatically be converted to the modality for which there are candidates.

# V REQUIREMENTS OF CANDIDATE FOR IMPLEMENTATION OF THE SCHOLARSHIP

According to Resolution No. 171 of April 27, 2017, of the Scientific-Administrative Council of the Espirito Santo Research and Innovation Support Foundation – CCAF/FAPES, the candidate for postdoctoral scholarship is required to:

- a) not carry out remunerated activity of any nature, except if the candidate has a connection with a Higher Education and/or Research Institution in another state or country, with due formal authorization or license to leave the institution of origin to carry out the post-doctoral internship.
- b) not be retired.
- c) have a CV registered on the Lattes platform.
- d) have a doctorate degree.
- e) present a Work Plan, in a specific FAPES form, with approval from the project coordinator and consent from the supervisor.
- f) not being a student in a medical residency program.
- g) comply with FAPES, the Federal, State and Municipal spheres, and the Labor Court.

# VI OBLIGATIONS OF THE POSTDOCTORAL SCHOLARSHIP

- a) Maintain compliance with the requirements listed in the previous item.
- b) Reside in the state of Espirito Santo during the duration of the scholarship.
- c) Comply with all activities foreseen in the approved work plan.
- d) Deliver activity reports within the scheduled deadlines.
- e) Inform/request the project coordination about modifications to the project (initial plan, execution schedule, objectives, etc.), with the supervisor's consent.
- f) Do not leave the institution where you develop your research project, except for the cases provided for in item 8 of Resolution No. 171/2017 of CCAF/FAPES.
- g) Refer to FAPES support in articles, books, summaries of work presented at meetings and any other publication or form of dissemination of activities that result, in whole or in part, from grants from the Foundation.
- h) Issue opinions on merit, free of charge, when requested by FAPES, on matters within their specialty and the deadlines requested by the Foundation.
- i) Inform the project coordinator and supervisor about absence and return from activities, abandonment, or withdrawal from participation in the project and exchange/change of the work plan.
- j) Maintain the movement of financial resources received, in a current account at BANESTES (State Bank of Espirito Santo).
- k) Return to FAPES any benefits received unduly. The amounts to be returned can be deducted from the monthly fees for beneficiaries with active scholarships.

# VII STEPS OF THE SELECTION PROCESS FOR THE POSTDOCTORAL FELLOWSHIP

# First step - Work Plan: 40 POINTS

The work plans must be prepared in line with the study themes, focuses and/or theoretical approaches of one of the Program's research areas and/or the research groups coordinated by the professors listed for supervision of the postdoctoral fellow (According to Appendix 2).

The candidate's work plan will be evaluated according to the following criteria:

I. Work plan		40 points

The candidate's updated curriculum vitae will be evaluated according to the documentation presented, covering the period from 2018 to 2023, according to the following criteria:
